The annual Downtown Williams Lake Art Walk is a free, self-guided tour through displays of artists' work in local downtown businesses. From August 9 to September 4, art enthusiasts will follow the Art Walk Guide to discover Cariboo arts and culture, visiting the many businesses where art pieces in various visual mediums will be displayed.

#### **BENEFITS OF BEING AN ART WALK VENUE:**

- 1. Your business name will be posted on Art Walk promotional materials print and digital.
- 2. Your business name, logo, address, and web links will be featured on the official Art Walk Guide, distributed at many Downtown Williams Lake locations.
- 3. You will see increased daily foot traffic into your business; Art Walk historically sees 500-800 participants.
- 4. Your business will be featured in cross promotion through the hosted artist.
- 5. You will beautify your space by displaying the original artwork of your hosted artist.

#### **BUSINESS REQUIREMENTS & SUGGESTIONS**

- Participating Art Walk businesses must be located within the Downtown Williams Lake BIA boundaries.
- Participating businesses will collaborate with their paired artist in hanging, displaying, and selling their work in the venue.
  - Participating businesses must clear their wall space or display area of any other wall hangings for the duration of the Art Walk (with the exception of permanent installations, utility panels, etc.) as required.
  - Artworks from the exhibitor should arrive to the venue with proper hanging requirements such as frames and wire hangers.
  - Artworks from the exhibitor **must** be displayed in a complete grouping in **one area** of the business. *Viewers should not have to walk throughout the business searching for individual pieces.*
- Hours of business will be posted in the Art Walk Guide, and businesses must adhere to those posted hours through August 9 September 4, 2024. Many new visitors may come into your business.
- Downtown Williams Lake BIA will be pairing businesses with fitting artists, based on subject matter, volume, and scale of their work.
- Participating businesses are strongly urged to do their own cross promotion of the event through newsletters, Facebook, Instagram, email lists, and word of mouth.



- Art displayed in my business may be removed from my venue at any time at the sole discretion of the Downtown Williams Lake BIA.
- It is my responsibility to work with my provided artist to develop ideal space, display, lighting and traffic flow- I understand it is my responsibility to coordinate the installation of their artwork on or before August 9 through September 4, 2024.
- It is my responsibility to work with the artist to coordinate all clean-up of the space once the event is finished on September 4, 2024, unless other arrangements are made in advance.
- In the event of a sale of a piece of artwork, 100% of the proceeds go directly to the artist.
- I agree to aid the hosted artist in any selling of their artwork.
- If an artist sells a piece, it may remain on display or must be replaced with another piece of art, until the end of Art Walk.
- I grant Downtown Williams Lake BIA permission to take photographs of my business, and grant Downtown Williams Lake BIA irrevocable worldwide license to use photographs of my entry/entries on event materials and the Downtown Williams Lake BIA website and social media.
- Downtown Williams Lake BIA does not cover expenses pertaining to the Art Walk displays in the business.
